



# PCAV Club Member Verification Form

Any dishonest, misleading or inappropriate use of this form will result in disciplinary action with the club member receiving a **three months minimum suspension** from all competitions.

This form is compiled in accordance with the PCAV *Handbook of By-Laws*.

## ABOUT THIS FORM

1. Only to be used if a PCAV club member card cannot be presented **due to loss or damage**. If a club member card has not yet been issued for the current year by PCAV, this form must not be used.
2. The form must be **fully completed before the member may ride**.
3. The zone representative may deny its use if deemed inappropriate. Such reasons may be – club member not making fair effort to replace card, frequent or misuse of verification form, use other than loss or damage.
4. The member's club DC, secretary or card secretary only may verify the club member's eligibility in accordance with the PCAV *Handbook of By-Laws* but is under no obligation to do so.
5. This form must be forwarded to the club member's zone representative within seven days.
